Directions

2. Create or select existing work-based portfolio artifacts for submission in Section 3
3. Create responses for Sections 2 and 3 that relate directly to the portfolio artifacts.
 - a. Responses should be added directly to this file (starting on page 2 below).
4. Review your submission to ensure that it meets each category's "Proficient" rating in the [grading rubric](#) for each section
5. Save this file with your final responses and [submit](#) on ADEA eLearn. Note that
 - a. Submissions are collected on January 15 and July 15
 - b. Allow up to for 8 weeks for review

Section 1, Question 1

Motivation: Why is this micro-credential meaningful for you? Please discuss the value this micro-credential has for you as a dental educator, with a special focus on how this micro-credential supports or enhances your professional development within dental education.

Section 1, Question 2

Training: Provide the three most significant resources that you used to develop your knowledge and skill of technology integration in didactic teaching. Examples include, but are not limited to, learning communities, activities, training, courses, research, study of literature or other formal or informal professional development experiences that you participated in. Describe each activity/resource and explain how it supported your learning and skill development in this area. You must include at least three examples and include citations or links for any resources that you cite whenever applicable. To the extent possible, demonstrate variety in the format or type of learning experiences that you discuss.

Section 1, Question 3

Key Features: From your research and/or training, what would you describe as the common components and characteristics of a teaching philosophy document? Are there any portions that are essential? Are there any which are optional? Which of them required the most development and reflection for you?

Community Engagement – Provide evidence of community engagement within the topic of developing a teaching philosophy. Acceptable evidence consists of attendance to a relevant conference, workshop, webinar or educational session on the topic, participation in an ADEA Connect discussion board, or engagement with a community partner in this topic area.

- d) How does your supporting documentation demonstrate the application of this teaching philosophy?

Section 2, Question 2

Relevant Ethical Considerations: Provide a summary and description of how your teaching philosophy communicates your personal code of ethics.

Section 2, Question 3

Supporting Diversity, Equity and Inclusion: How can a teaching philosophy be developed so that it supports diversity, equity and inclusion efforts within a dental education setting? Provide one to two examples of how your teaching philosophy was developed to meet the needs of a diverse student population.

Supporting documentation should demonstrate your application of the teaching philosophy statement through such methods as peer-reviewed manuscripts, lesson plans, learning activities, learning session materials (files or recordings), learner assessments, videos, presentation recordings, case studies, case materials for use in educational settings, workshop materials. The teaching philosophy statement and supporting material should be the focus of your previous responses in Sections 1 and 2.
